RE: **FCC License Assignment Application Public Notice: WESP, WJRL-FM, WBBK-FM and WECB**

FCC Public Notice of the filing of the application for consent to the assignment of WESP, WJRL-FM, WBBK-FM and WECB (the “Stations”) was released on February 22, 2024. Each of the Stations must broadcast six post-filing announcements and also place public notice on the “FCC Applications” page on its website. This memo provides instructions for the announcements and website notice.

There are two steps for complying with these requirements:

- Beginning the week of February 26, 2024, each Station must broadcast six announcements. The text and schedule of the announcements are below.
- No later than February 29, 2024, each Station must place the text of a public announcement on the “FCC Applications” page of its website. This notice must remain on the website for at least 30 days. The text of the announcement is below.

Schedule for Broadcast Announcements

The broadcast announcements (text below) should air on the primary programming stream of the station any time between 7 a.m. and 11 p.m. (local time) on the following dates:

1. Twice between February 26 and March 1, inclusive (do not air both on the same day).
2. Twice between March 4 and March 8, inclusive (do not air both on the same day).
3. Twice between March 11 and March 15, inclusive (do not air both on the same day).

If an announcement is missed, you should air it on the next business day, any time between 7 a.m. and 11 p.m., except that no more than two announcements should air in any single week.

Text of Announcement for Broadcast

“On February 20, 2024, Alabama Media, LLC, licensee of radio station [Call Sign, Frequency and Community of License of Station; e.g. WESP(FM), 102.5 MHz, Dothan, Alabama], filed an application with the Federal Communications Commission for assignment of the station’s broadcast license. Members of the public wishing to view the application or obtain information about how to file comments and petitions on the application can visit <https://publicfiles.fcc.gov/>, and search [Call Sign’s] public file.”

Text of Announcement for Website

“On February 20, 2024, Alabama Media, LLC, licensee of radio station [Call Sign, Frequency and Community of License of Station; e.g. WESP(FM), 102.5 MHz, Dothan, Alabama], filed an application with the Federal Communications Commission for assignment of the station’s broadcast license. Public File Certification
